Buyers Protection Group, Inc. to Acquire LandAmerica Home Warranty and Property Inspections Companies *Current Employees and Management Pursue Purchase*

ATLANTA, GA (PRNewswire) – May 27, 2009 – Buyers Protection Group, Inc. ("BPG"), an Atlanta-based real estate services firm, has signed a definitive agreement to purchase two subsidiaries from LandAmerica Financial Group, Inc. ("LandAmerica"). The acquisition is subject to regulatory approval and is expected to close later this summer.

LandAmerica Home Warranty Company, founded in 1987, provides one-year home warranties in 30 states with concentration in AZ, CA, and TX. LandAmerica Property Inspections Inc. was started in 2001 and is now the nation's largest employee-based inspection company providing residential and commercial inspections in 14 states, including 25 key metropolitan real estate markets. Both companies will undergo name changes upon completion of the acquisition.

BPG was established to support the current management team and employees in purchasing the companies from LandAmerica. When the transaction closes, BPG will have more than 250 employees and will maintain dual operation centers in Burbank, CA and Alpharetta, GA. The Company plans to implement a controlled expansion strategy leveraging the existing footprint of the two businesses.

"We believe the home warranty and inspection businesses are both solid companies with great reputations," said BPG President and CEO, Revell Fraser. "We are well positioned to leverage our passion, focus, and financial strength to deliver distinct value and growth as an independent company."

"Both businesses have remained profitable and service-oriented during an extremely difficult downturn," said Robert Covington, a Principal at The Stephens Group which owns a majority interest in BPG. "Their strong business ethics and proven ability to execute a well developed strategy will drive even more success as the housing market begins to normalize."

BPG was advised by Croft & Bender LLC in Atlanta, Georgia and has partnered with The Stephens Group in Little Rock, Arkansas on the transaction.
